WHEREAS, on or about June 21, 2022, the Supreme Court, Albany County, Honorable Acting Justice Sara W. McGinty, issued a Decision/Order/Judgment dismissing the District's Petition, brought pursuant to Article 78 of the NY CPLR, appealing Decision No. 18058 of the Commissioner of Education, ordering that the Board's resolution on July 8, 2021 entitled "CCS NICKNAME & IMAGERY RESOLUTION v.2" is annulled, and further ordering that the Board "eliminate the use of its former team name, mascot and logo in accordance with its resolution dated June 17, 2021, by no later than July 1, 2022; and,

WHEREAS, on or about June, 22, 2022, Justice McGinty issued an Amended Decision/Order/Judgment concerning the same; and,

WHEREAS, the Board, while mindful of the ramifications of Justice McGinty's and Commissioner Rosa's prior decisions, wants to keep open the legal options and remedies that might be available to the extent it decides to further appeal those decisions.

BE IT RESOLVED, that the Board hereby authorizes its attorneys, Honeywell Law Firm, PLLC, to file a Notice of Appeal concerning the Article 78 proceeding, from the Judgment of Justice McGinty, and to take legal action consistent with such filing; and,

BE IT FURTHER RESOLVED, that the President of the Board of Education is authorized to execute any legal documents as may be necessary with respect to such filing.
